2. The price reported in Column 4 is a weighted average price. These shares were sold in multiple transactions on (1) June 2, 2021 at prices ranging from \$41.71 to \$42.705 for the sale of 42,206 shares and a range of \$42.71 to \$43.52 for the sale of 28,123 shares, (2) June 3, 2021 at prices ranging from \$40.64 to \$41.635 for the sale of 69,234 shares and a range of \$41.64 to \$42.08 for the sale of 17,766 shares, and (3) June 4, 2021 at prices ranging from \$39.13 to \$40.12 for the sale of 34,680 shares, a range of \$40.13 to \$41.08 for the sale of 68,404 shares, and a range of \$41.15 to \$41.91 for the sale of 5,787 shares. The undersigned undertakes to provide New Fortress Energy Inc. Jonathan Rotolo and Alexander Thomson are the managers of Great Mountain Partners LLC and, in that capacity, have voting and dispositive power over the Class A Shares held by NFE SMRS Holdings LLC and therefore may be deemed to beneficially own such shares. Each of Great Mountain Partners LLC, Mr. Rotolo and Mr. Thomson disclaims beneficial ownership of the shares, except to the extent of their pecuniary interest therein.
